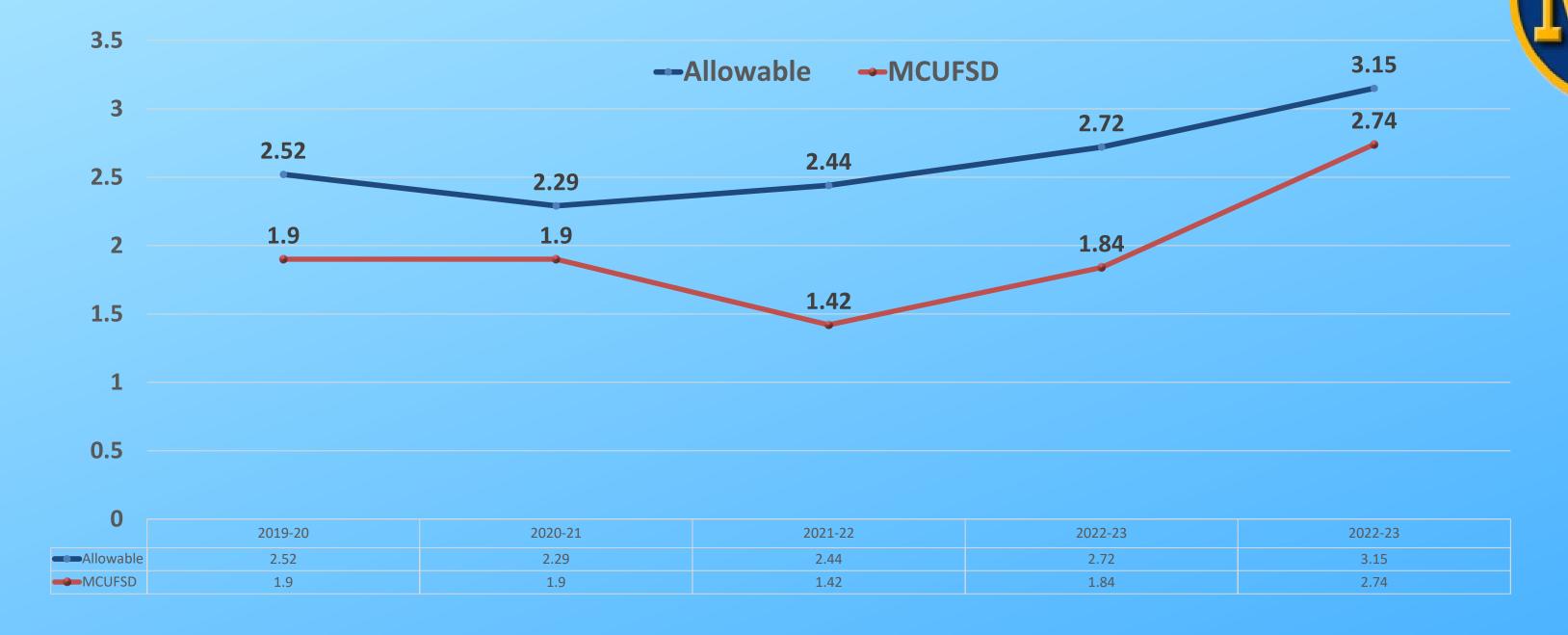


Two Propositions On Ballot In May:

Proposition #2 – Expend \$4,391.454 from the Capital Reserve established on May 17, 2022, for following projects:

- > Recoating and Repairing remaining roof sections at the Mattituck Junior Senior High School cost \$2,957,903
- > Recoating and Repairing remaining roof sections at Cutchogue East Elementary School- cost \$1,433,551
 - > Since the funds are to be expended from the Capital Reserve fund **no effect** on the tax levy
 - > Community approval required to authorize expending of funds

Tax Cap History

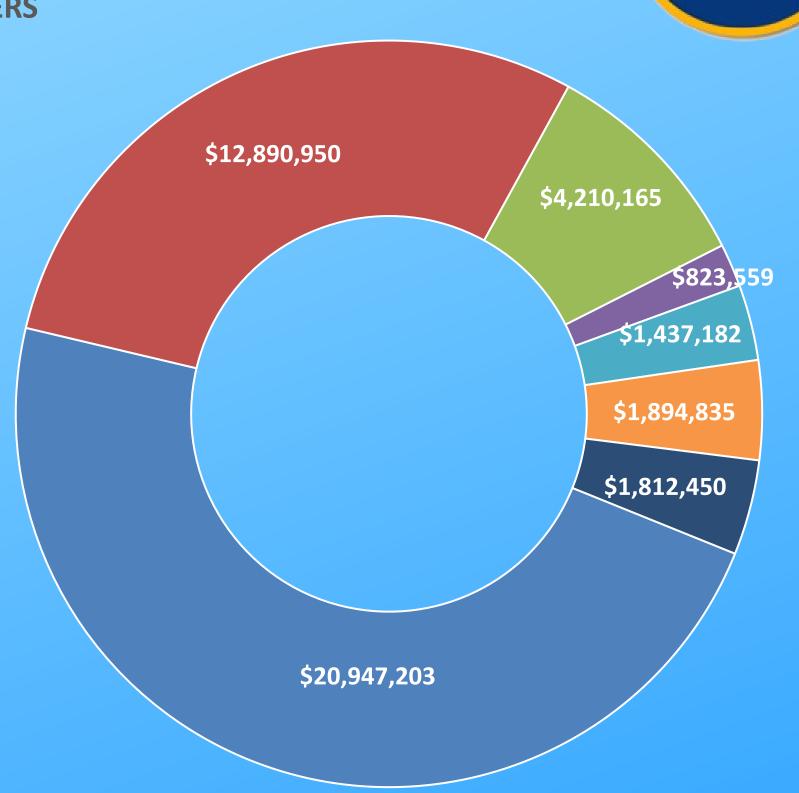


- The Property Tax Cap, imposed in 2012, limits tax-levy increases to 2 percent, with certain exceptions, or the rate of inflation, whichever is lower.
- The statewide allowable tax-levy increase, calculated by the State Comptroller's Office, is a baseline figure. Every year, each school district has its own tax-cap limit.

- For 2022-23 there were 26 Elementary General Education Teachers in the budget.
- For 2023-24 there are presently 24 Elementary General Education Teachers in the budget.
- We anticipate a decrease of approximately 34 students next year.
- These totals do not include Special Class students.
- We must continue to watch enrollments in K and 4th grade.
- This budget does not include the Cutchogue East Assistant Principal position.
- This budget does include the creation of a Cutchogue East Dean position for grades 3-6.
- This budget does include the K-6 Guidance position that will expand the role to support students and services.

- Librarian retirement at MHS to be replaced with a Library Aide.
- District wide this budget absorbs 7.45 FTE's
 - This is being done through 4 retirements, 1 resignation, reduction in the use of 6th classes at MHS, movement to other certification areas, partial staff decreases in PE, Music, and Art.
 - This budget does have an increase of .4 FTE for the Carpentry program and .5 FTE for ENL.

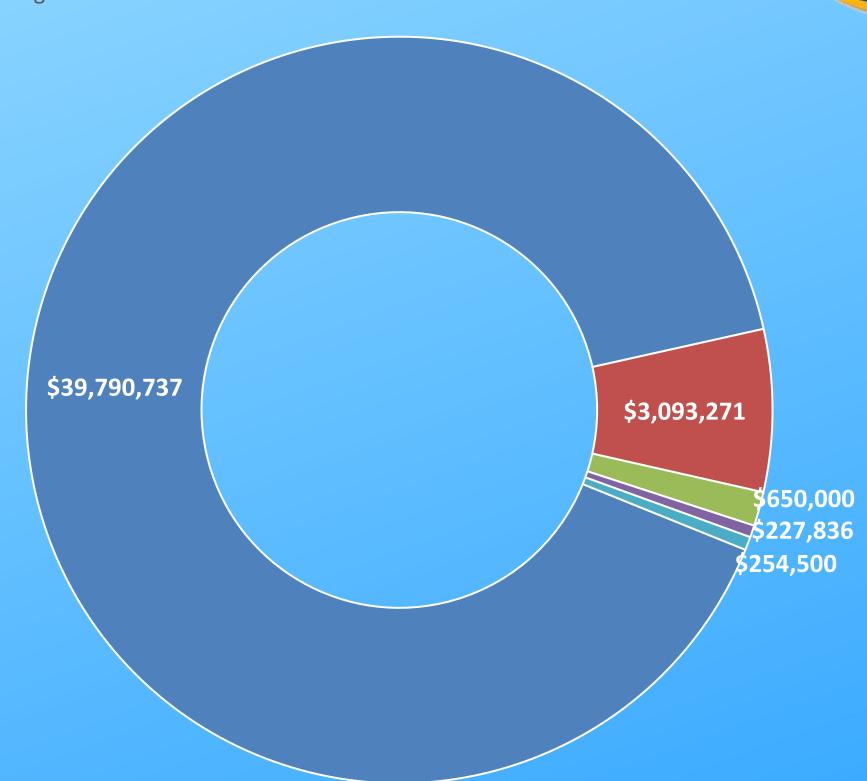
