A Message From the Board of Education

Dear Neighbor:

Our annual school budget is an ongoing cycle, during which we are able to develop a proposed budget that preserves all existing academic and extracurricular programs while also bringing new initiatives to the district. The proposed budget outlined in this newsletter allows us to maintain class sizes, addresses the need for ongoing technology developments and provides for additional extracurricular clubs as well as necessary districtwide capital repairs, including lighting, bathroom renovations and a handicap ramp for Mattituck High School.

Teachers and administrators throughout the district have been hard at work developing curricula that equip all of our students with the necessary skillsets to meet with success after graduation – whether they choose college or career – while continuing to stress the vital importance of respect, citizenship and ethical behavior.

At the same time, we have made a deliberate and forthright effort to propose a responsible budget that remains below the tax levy limit set by the state, in spite of minimal additional state aid. By continuing to draw upon reserves and utilizing grant funding, the proposed budget carries a tax levy increase of 1.9%. This is less than the 2.52% allowable Mattituck-Cutchogue tax levy.

In addition to the proposed budget, we are presenting two propositions for residents



to consider. These propositions are described in more detail on page 3. These propositions will seek voter approval to expend funding from the capital reserve fund that was established and approved last year.

In closing, the proposed budget will preserve and enhance the many wonderful programs that define excellence in Mattituck-Cutchogue with a budget increase of only 0.26%, or \$107,101, from last year.

The budget supports enriching educational opportunities for all students, improving the learning environment, leveraging district investments to expand safety and security, and maintenance.

PROPOSITION HIGHLIGHTS

Proposition No. 1: 2019-2020 Budget

Proposition No. 2: Authorization to Expend Capital Reserve Funds for Security and Air Conditioning.



This proposition requests permission of the community to expend \$1,960,000 from the capital reserve fund (essentially a savings account) to pay for districtwide security upgrades including, but not limited to, interior door replacements, locks and security film. Air conditioning will be installed in both the Mattituck Junior/Senior High School and Cutchogue East Elementary School cafeterias.

Proposition No. 3: Authorization to Expend Capital Reserve Funds for a Synthetic Turf Field

No Additional Cost to Taxpayers

This proposition requests permission of the community to expend \$1,600,000 from the capital reserve fund (essentially a savings account) to pay for a synthetic turf field including, but not limited to, a turf field excavation, drainage, bleacher pad, dugouts, retaining wall, fencing, and ADA compliant sidewalks and curbing.

MORE INFORMATION ABOUT THE 2018 CAPITAL RESERVE FUND

Q. What is a capital reserve fund and is it common?

A. It is similar to a personal savings account which is funded over time and typically used to pay for both planned and unforeseen major expenditures. Many school districts have established capital reserve funds since the tax levy cap began in 2012.

Q. When did the district establish a capital reserve fund?

A. In May, 2018, the community approved the

creation of a capital reserve fund to be funded up to \$6 million over a term of 10 years.

Q. How much is currently in the capital reserve fund?

A. Currently, there is \$3,750,964 million in the capital reserve fund.

Q. How is there no impact to the budget and tax levy?

A. All expenditures are paid from the capital reserve fund. This fund has no effect on the total

budgeted expenditures and tax levy calculation.

Q. Does the district plan to continue to fund the capital reserve fund?

A. Yes. As part of the district's reserve fund planning, the district can continue to add up to \$750,000 a year for future identified capital improvements, renovations, repairs and/or enhancements. This can be funded by any money remaining in the general fund at the end of each year or transfers from other reserves.

ELECTION OF BOARD OF EDUCATION TRUSTEES

Residents will be asked to vote for the election of two Board of Education trustees. One term will commence May 21, 2019 and expire June 30, 2022, and one term will commence July 1, 2019, and expire June 30, 2022. The two candidates with the highest pluralities of the votes cast will be elected to the Board of Education. The candidate receiving the highest number of votes will receive the longer term of office.

BUDGET VOTE AND BOARD ELECTION

Residents will be asked to vote on the proposed budget, two propositions regarding the expenditure of a capital

reserve fund and the election of two Board of Education trustees. All residents who are already registered for school district or general election are eligible to vote on Tuesday, May 21.

REQUIREMENTS FOR VOTING

To vote, you must be a U.S. citizen, at least 18 years of age and a resident of the school district for a period of at least 30 days prior to the date of the vote.

REGISTRATION

Residents can register in the district clerk's office between 9 a.m.-4 p.m. any day school is in session, up to and including Wednesday, May 15.
