A Message From the Board of Education

Dear Neighbor:

We hope this message finds you and your family safe and well as we continue to cope with the impact of a health pandemic unlike any other in our lifetime. Our condolences to those who have experienced hardship or the loss of a loved one. Our sincere gratitude to the members of our community who put saving the lives of others before their own lives. You are truly heroes and role models for our children to emulate.

As we look forward to a brighter future, the Board of Education and administration have continued working throughout this time to finalize a proposed 2020-2021 school budget that has been reduced to acknowledge the changing economy. The proposed budget represents a 1.75% tax levy increase, which is significantly lower than the allowable tax levy cap of 2.29%. Once again, this increase is one of the lowest on Long Island.

This proposed budget maintains all current programs and student offerings. It provides numerous enhancements, including new coursework at the high school level, updated math materials aligned to the Next Generation Learning Standards for grades 5-8, and advancing K-12 STEAM education. In addition, we have included extracurricular activities and a unified sports program for our most challenged students, and security upgrades to ensure the safety of our students and staff. Thanks to the ongoing success of partnerships established within our community, we will continue to preserve and promote future life-readiness experiences for our students through internships and civic-minded educational experiences.



Residents will be asked to vote on expending funds from the previously voter-approved Capital Reserve Fund to support needed repairs and renovations. Furthermore, approval is being requested by voters on the creation of a Repair Reserve Fund for ongoing or emergency repairs as needed, both at no additional cost to taxpayers.

In summary, despite these unprecedented and challenging times, we are committed to our community to be fiscally responsible. We are pleased to present a proposed budget that is both below our allowable tax levy cap and preserves and expands the quality educational opportunities we as a community expect for our children.



PROPOSITION HIGHLIGHTS

Proposition No. 1: 2020-2021 Budget

Proposition No. 2: Authorization to Expend Capital Reserve Funds.



This proposition requests permission of the community to expend \$650,000 from the Capital Reserve Fund (essentially a savings account) to pay for a new boiler at Cutchogue West, a new roof at Cutchogue East and a multipurpose room renovation at Mattituck Cutchogue Jr.,/Sr. High School.

Proposition No. 3: Authorization to Create a Repair Reserve Fund.

This proposition requests permission of the community to establish a Repair Reserve Fund, essentially a savings account, which is funded over time and typically used to pay for repairs and renovations. The Repair Reserve Fund can be funded up to \$750,000 from annual budgetary appropriation and/or monies remaining in the general fund.

MORE INFORMATION ABOUT THE 2018 CAPITAL RESERVE FUND

Q. What is a Capital Reserve Fund and is it common?

A. It is similar to a personal savings account which is funded over time and typically used to pay for both planned and unforeseen major expenditures. Many school districts have established capital reserve funds since the tax levy cap began in 2012.

Q. When did the district establish a Capital Reserve Fund?

A. In May, 2018, the community approved the

creation of a Capital Reserve Fund to be funded up to \$6 million over a term of 10 years.

Q. How much is currently in the Capital Reserve Fund?

A. Currently, there is \$2,574,291 in the Capital Reserve Fund.

Q. How is there no impact to the budget and tax levy?

A. All expenditures are paid from the Capital Reserve Fund. This fund has no effect on the total

budgeted expenditures and tax levy calculation.

Q. Will future voter approval be required to fund projects from the Repair Reserve Fund?

A. No. Unlike the Capital Reserve Fund that requires voter approval for every project, the Board of Education can authorize the use of funds from the Repair Reserve Fund. The Board of Education is required to hold a public hearing to review the work and costs associated with each project.

ELECTION OF BOARD OF EDUCATION TRUSTEES

Residents will be asked to vote for the election of two Board of Education trustees. Both terms will expire June 30, 2023. The two candidates with the highest pluralities of the votes cast will be elected to the Board of Education.

BUDGET VOTE AND BOARD ELECTION

Residents will be asked to vote on the proposed budget, two propositions and the election of two Board of Education trustees. The propositions, if aproved, would support the capital reserve fund and the creation of a repair reserve fund. All residents who are registered for school district or general elections are eligible to vote.

REQUIREMENTS FOR VOTING

To vote, you must be a U.S. citizen, at least 18 years of age and a resident of the school district for a period of at least 30 days prior to the date of the vote.


